15. Multidisciplinary / interdisciplinary

The institute offers educational programs which emphasize on developing a creative attitude with stress on multidisciplinary and interdisciplinary approach. Students here enjoy freedom in thinking process, which is a pre-requisite for a creative field like architecture. The institute's vision is to reach global standards by deliberate modernization without losing the essential characteristics of our tradition for transforming itself into a holistic multidisciplinary institution. With the institutional approach towards integration of the humanities and sciences with STEM, we offer several electives like Design of Building Elements, Advanced Spatial Analysis, Rural Architecture, Heritage Documentation, Environmental studies, Appropriate technology, Green architecture, Environmental psychology, and Man and Environment relationship. These issues are also taken up in design studios and thesis projects. Innovative transmission of knowledge is uniqueness of the institute in which current issues and challenges are the focus of studio subjects for U.G. and P.G programs which are imparted through multi-disciplinary courses. Community engagement We wish to produce socially responsible architects with sensitivity towards social issues of immediate contexts, national concerns and global effects. The subject of Research in the 7th semester promotes the students to engage in multidisciplinary research endeavours to find solutions to society's most pressing issues and challenges; for e.g. Courtyards & Human Interactions, Analyzing the Change in Built Environment in Separated Marathi families in Nagpur, Changing Literacy Rate in Kachipura Slum Area, Nagpur etc. Environment and Sustainability Subjects like Climatology and Climate & Architecture are taught as early as 2nd and 3rd semester to inculcate understanding of environment and related issues in students. Additionally, there are electives like environmental studies, appropriate technology, green architecture, environmental psychology and man and environment relationship offered in various semesters. Institute has been conducting various social events such as tree plantation, rallies on energy conservation. A MoU with IGBC is done to conduct activities for students such as seminars, lectures and quizzes etc. for increasing awareness about environment and sustainability. Human values: A necessary part of our approach is to inculcate Human Values among students. Our institute always believes to make each student to be good human being and responsible architect. Through design assignments, thesis projects and dissertations the students deal with universal design, cultural aspects and human values in their studios. Provision for multiple entry and exits

at the end of 1st, 2nd and 3rd years of undergraduate education has be implemented by the RTM Nagpur University to which we are affiliated. Committed to overall academic excellence through exploration of diverse contexts and innovations through collaborative research the institution plans to engage in more multidisciplinary research endeavours to find solutions to society's most pressing issues and challenges. Pedagogy in Architecture education is the USP of the institute and is well integrated in teaching methods to help the students learn differently. The institute encourages innovative pedagogy through group activities, group research, extensive use of documentary films, the internet, field visits, interaction with scholars and activists and peers, etc.

16.Academic bank of credits (ABC):

The UGC ABC (Academic Bank of Credits) has heralded a muchrequired change in the existing higher education system and will promote customised learning paths for students. The ABC program has revolutionised the way we understand higher education in India. Bringing unprecedented democracy to learners, the ABC will create customised learning paths for students when leveraged properly. The National e-Governance Division (NeGD) of the Ministry of Electronics and Information Technology (MeitY) has created the Academic Bank of Credits (ABC) platform, which is based on the DigiLocker framework and provides the ability for students to open Academic Accounts and for Higher Educational Institutions (HEls) to sign up. The credit bank will be an online repository where students' academic credit, calculated on the basis of classwork and tutorials, will be stored. This will offer seamless student mobility between or within degree-granting Higher Education Institutions (HEIs) through a formal system of credit recognition, credit accumulation, credit transfers, and credit redemption. Credits deposited on the ABC platform will be valid for a maximum of seven years or the duration specified for a given discipline. The institute is undertaking the following steps to join the ABC (Academic Bank of Credits) program - Registration of institute under ABC (www.abc.gov.in) -The institute is affiliated to Rashtrasant Tukadoji Maharaj Nagpur University. The university is required to upload a list of institutes affiliated to it on the ABC platform, after which the institute name will be available in the drop down menu. After this process the institute will get registered on the ABC platform. The institute is in co-ordination with the Nodal Officer of RTM Nagpur University for the same. Orientation sessions have been conducted for the students of all years on the

creation of ABC account on the ABC portal. All our students have registered and have received their ABC ID. The year-wise list of the student ABC IDs will be sent to RTM Nagpur University as well. A Nodal officer has been appointed at the institute and he will be doing the co-ordination work for ABC. All the examination forms sent to the RTM Nagpur University will have the ABC IDs mentioned on them. The institute will be very soon creating a hyperlink to the ABC portal - www.abc.gov.in on its official website. In view of implementation of NEP 2020, the institute is has implemented following good practices which will help the students in garnering academic credits - The institute has been recognized as an active Local Chapter of NPTEL since 2020. Students are actively encouraged to undertake courses and get certification from various curriculum-related courses on NPETL. Several students and teachers have benefited from these courses. The institute will continue to undertake inter-institutional partnerships to elevate quality in education through collaborative process.

17.Skill development:

The institute is driven by the mission to enlighten, empower and socially uplift women through access to higher, technical and vocational skills education, and soft skills of students in alignment with National Skills Qualifications Framework. The thrust, thus, is to hone the inherent skills and develop design and technical acumen rather than rote learning. Teaching learning at SMMCA is focused on hands-on experience, creative exercises, and exposure to real-life experiences. Skill development is an integral part of the entire curriculum at both under-graduate (B.Arch.) and Post-graduate (M.Arch.) levels and vocational education is promoted and integrated into mainstream education. Skill development teaching units for various subjects offer flexible and innovative curricula that include credit-based courses. Few other projects are designed to focus on the areas of The institute is a local community engagement and services. chapter for NPTEL Swayam courses; students are encouraged to register for various courses which would enhance their skill set. Various programs are conducted through National Service Scheme (NSS) with goal of education through service for developing personality and character of the student youth, and build an additional skill set through voluntary community service. Choice based Credit System (CBCS) is offered by the affiliating RTM Nagpur University. Courses like Building Information Modelling (BIM), Revit, Prima Vera, presentation skills, public speaking etc. are offered. Students are encouraged to undertake as many

vocational courses as possible in order to widen their skill base. Visits to construction sites, education tours to places of architectural interests, and manufacturing places are regularly conducted to provide vocational skills and overcome gaps vis-àvis trained faculty provisions. Construction yard activity is an annual activity which equips students with hands-on knowledge of construction and helps bridge the gap between theory and practice. Various hands-on workshops like Design Jatra, Makers Adda, etc. enhance the skills of students. Working under renowned practicing architects for training gives the student's good exposure to the professional practices. SMMCA's Design and Research Consultancy Cell and Documentation Cell introduce advanced skills and opportunities for the students. The involvement in these cells ensures that the faculty and students get the knowledge and practical skills required for the architecture profession. Two Valuation courses has been started from the academic year 2022-23 under the Lifelong learning board of the affiliated RTM Nagpur University. The courses on Real Estate and Security and Finances for diploma, Advance Diploma and Postgraduate diploma are conducted in online mode so that students from all over India can take advantage of it. The institute takes efforts to offer vocational education in ODL/blended/on-campus modular modes to Learners. Overall, the skill development strategies ingrained in the courses fulfil the requisite needs by providing exposure, hands-on experience, and a platform where every student is trained towards skills needed in the architecture industry through academic and co-curricular programs like expert lectures, symposia, workshops, panel discussions, hands-on activities, etc.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

In order to make India a global knowledge superpower, National Education Policy envisions an education system anchored in Indian culture that directly contributes to changing India, or Bharat, sustainably into an equal and vibrant knowledge society. Value based education courses like Traditional arts & crafts, Regional architecture, Building bye laws and DCR, Professional practice etc. inculcate amongst the learner the development of humanistic, ethical, Constitutional, and universal human values. For Joint studio (a yearly feature), design studios, thesis dissertation etc. varied issues pertaining to Indian ancient traditional knowledge, Indian culture and tradition, Indian art, social issues identified and addressed so as to sensitize patriotism and human values in students. Students are given exposure to our

cultural knowledge through electives such as Art and Appreciation, Rural architecture, etc. SMMCA's vision is to reach global standards by deliberate modernization without losing the essential characteristics of our tradition. SMMCA is one of the main Non-Formal Sanskrit Education Centres for learning informal Sanskrit under "The Central Sanskrit University". The Central Sanskrit University has the unique distinction of being the largest and the only multi-campus language university in the world. Traditional Indian system of architecture is based on ancient texts that are written in Sanskrit. Sanskrit also provides the theoretical foundation of other ancient sciences. SMMCA is registered with "Rashtriya Sanskrit Sansthan" since 2016 as a main Centre helping for the development and promotion of Sanskrit among the students of architecture and other technical branches. Students opt the Sanskrit language as one of the electives at 1st and 2nd semester levels. SMMCA also has a very active Documentation Cell which is the Nodal Agency for Heritage Conservation appointed by the Nagpur Municipal Corporation. Under this aegis the institute has documented several heritage structures of the city and has given consultancy for the maintenance of important heritage structures. SMMCA also has a Heritage Club in association with INTACH, through which students imbibe knowledge about our traditional knowledge systems present in our art and architecture. History of Architecture is one of compulsory subject in which history of Indian Architecture is covered. The objective of the course is . Traditional Arts and Crafts subjects cover Diversifying culture, heritage, Rituals and beliefs, Religion and festival, Language and custom, food habits, Dressing, History (Early civilisation) or mythology, Heritage etc.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The curriculum at SMMCA is transformed towards Outcome based Education (OBE). The PSOs, POs and COs are designed in lines with the Council of Architecture (CoA) norms, RTM Nagpur University, Women's Education Society (WES) management and the Institution's vision and mission statement. The program outcomes are carefully fixed studying the graduate attributes and blending those appropriately to suit the program being offered. Each course has specific course outcomes which are discussed in the meeting which are compiled in form of an academic booklet. For knowing the attainment level meetings are conducted in beginning, in between and at the end of the semester. For each course, attainment level of all course outcomes is arrived at rigorously based on the student's output in drawing subjects and performance in the

internal and external examinations for theory subjects. The result of the examination is analysed to identify the grey areas which are addressed in the forthcoming semester. Similarly, the feedback at the end of course is taken to assess the course outcome indirectly. Thus, the CO attainment is a combine result of direct and indirect assessment. This in turn helps in arriving at the PO assessment as each CO is mapped with certain POs and PSOs. Besides this, feedback for teaching is taken from students for indirect assessment of the PO's. Architecture curriculum is an applied course where the theoretical learnings are expected to be applied in studios to develop design skills. Institute has a long tradition of experiential learning through study tours, live projects and live site studies which helps in achieving the target of Outcome Based Education. The initiatives by the institute to transform formally its curriculum towards outcome based education includes: a. Framing of learning objective for every design studio project b. Framing of the evaluation criteria for qualitative assessment. c. Flexibility and choice for students to specifically choose projects or electives to be taken up in the broader framework These initiative helped to develop outcome amongst the students such as development of Life skills, Professional and vocational skills, Interpersonal communication skills The good practice/s of the institution pertaining to the Outcome based education (OBE) in view of NEP 2020: Studio project on the initiative by the Hon. Prime Minister "Atmanirbhar Bharat" under which students picked up three villages nearby Nagpur and studied its socio-economic context and proposed infrastructure development to make them self-sufficient. The vertical studio 2021-22, conducted for 5th and 7th semester students, was focused on study of the National Education Policy 2020. Students were asked to understand the nuances of the NEP and design a campus of a college as per NEP.

20.Distance education/online education:

It is recommended under the National Education Policy (NEP)-2020 to increase the Gross Enrolment Ratio in higher education including vocational education and to further promote Open and Distance Learning (ODL) and online education. With his vision Smt. Manoramabai Mundle College of Architecture was given approval for starting 6 online distance education courses in 'Valuation' under the Life-long Learning Board of Rashtrasant Tukadoji Maharaj Nagpur University from the academic year 2022-23. The approved course were as follows - Valuation of Real Estate - Diploma Advanced Diploma PG Diploma Valuation of Securities or Financial Assets - Diploma Advanced Diploma PG

Diploma The institute commenced online classes for Diploma and PG Diploma in Valuation of Real Estate from August 2022 with students enrolled from various cities all over India. These courses are taught by experienced senior faculty and professional faculty offering a distinct advantage to the students taking admission to each course. Online Education: The institute took this COVID 19 situation not only as a challenge but as an opportunity to grow and to revitalize the traditional methods of education. Due to this new mode of teaching an entirely new approach towards teaching and learning was conceived through the following channels - Online classes of theory subjects. Online conduction of studio subjects like Design, Construction, Working Drawing, etc. with mentoring system. Online Guest Lectures for enhancing subject teaching through inputs of experts. Conduction of several National & International webinars which benefitted not only the institute students but academicians, architecture professionals and students from all over the country. of Faculty Development Programs in online mode for teachers of architecture from all over India. Rejuvenation of all student clubs on the online platform and conduction of several activities like online workshops, competitions, etc. Initiation of new online resource portal as a repository for online teaching learning content. 'Pradnya Darpan', an online exhibition of the SMMCA student academic work was launched which greatly benefited the students as the annual physical exhibition of student work was not possible. Even after commencement of fully offline mode of teaching - learning from March 2022 onwards, as the efficacy and advantages of online mode of education were well established and requisite infrastructure upgraded during the pandemic situation, the institute continues some of the online practices like - conducting expert lectures and subject modules in online mode, online FDPs, online exhibition of student work, etc. in order to continue extending the benefits to the students. The institute has been recognized as an active Local Chapter of NPTEL since 2020. The institute actively encourages students to undertake courses and get certification from various curriculumrelated courses on NPETL.

CURRICULAR ASPECTS

1.1 - Curricular Planning and Implementation

1.1.1 - The Institution ensures effective curriculum delivery through a well planned and documented process

SMMCA aspires to achieve global benchmarks through intentional modernization while maintaining our essential traditions. Our mission is to elevate architectural education for women, thereby empowering and enlightening them.

The academic and administrative leaders assist the principal in various institutional activities. To align with the institute's vision, there are four core subject Chairs: Professional Practice, Architectural Design, Construction Technology & Materials, and Building Services, each responsible for specific learning outcomes.

For undergraduate programs, there are annual in-charges. Eighty students are divided into two classes of forty, with a class coordinator selected each semester to ensure consistent course delivery. Postgraduate programs have a single in-charge who manages the curriculum's implementation.

A standout feature of our institute is its innovative approach to knowledge transfer. Studio courses for both U.G. and P.G. programs focus on contemporary issues and challenges, with students engaging in practical, creative exercises and realworld experiences.

Educational tours in the architectural curriculum are major exercises in experiential learning. Students on such visits are exposed to various architectural issues and gain knowledge.

These procedures ensure a structured evaluation of design projects.

Building Construction

Building construction is an integral part of the architecture.

Conventionally subject of construction was taught as a theory subject and focused on drawing sheets to improve students' understanding. To improve the quality of drawing sheets and the understanding of students, Institute has developed a Policy that stated that:

- Students will work on sheets during the class itself and tests would be conducted, in which drafting questions will be compulsory to give practice to students.
- Experiential learning sessions like site visits and handson experience i.e., construction yard activity, the industrial visit is made mandatory.

Solid Waste Management: The institute emphasizes proper segregation of waste at the source with separate bins for dry and wet waste. Collected waste is handed over to the municipal waste collection agency. Organic debris and waste paper are processed in compost pits to produce manure for gardening and landscaping.

Liquid Waste Management: Campus sewage water is managed through a proper drainage system, directing sewage and sullage to septic tanks for safe disposal. A grease trap outside the hostel kitchen intercepts grease and solids, preventing blockages and maintaining drainage efficiency. Winter Drawing Competition The 15th Annual Winter Drawing Competition, organized by SMMCA, promotes awareness of architecture and environmental issues among school children and the general public. Its objectives include introducing architecture as a profession across diverse age groups and fostering creativity through engagement with socio-environmental themes. Participants, ranging from nursery to 12th grade, are categorized by age, and themes are tailored to contemporary

issues. The event attracts 400-600 students annually, with schools now eligible for a "Maximum Participation Award" to acknowledge their contributions. Despite logistical challenges, such as extensive communication with schools, the competition has consistently enhanced students' creative abilities and architectural awareness, highlighting interdisciplinary learning.

Vertical Studio - Bamboo Workshop The Vertical Studio on Bamboo Workshop, held annually at SMMCA, focuses on sustainable construction practices. It introduces students to bamboo as a renewable building material with high tensile strength. From March 12-14, 2024, vertical groups of students participated in practical sessions on bamboo properties, joinery techniques, and structure construction. The workshop, supported by the Bamboo Development Board, improved students' understanding of sustainable materials and teamwork. Despite initial challenges, such as unfamiliarity with bamboo and time constraints, it successfully produced stable and aesthetic structures, fostering eco-consciousness and interdisciplinary collaboration.

Environment and Sustainability: The curriculum includes subjects like Climate & Architecture, Green building and Climatology. Additionally, electives such as Appropriate Technology and Man and Environment Relationship are offered across various semesters.

Therefore, visits toconstruction sites, education tours to places of architectural interest, and manufacturing facilities are regularly conducted. Various workshops like hands-on workshops, construction yard, etc enhance learning abilities. Working under renowned practicing architects for training and Design Cell participation give the students requisite exposure.

Participative learning- Interactive classroom culture is followed, to get students actively involved in the learning process to get new ideas. Involvement in Design Cell projects enhances their learning experience.

Methodologies such as group interactions and role play among the students make learning interactive. Students are encouraged to participate in many activities at local, national and international level to nurture their creativity.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The Institution has adequate infrastructure and physical facilities for teaching-learning. viz., classrooms, laboratories, computing equipment etc.

The institution has the adequate infrastructure required for effective Teaching-Learning process, co-curriculum and extracurricular activities. The infrastructure has required facilities to fulfil the norms laid by the Council of Architecture (CoA), RTM Nagpur University and the Government of Maharashtra Directorate of Technical Education(DTE). Apart from the institution's infrastructure, the college shares the infrastructure facilities with WES's LAD and RP College for Women's Shankar Nagar Campus and Seminary Hills Campus. These shared facilities include the Central Library of the campuses, sports and cultural facilities, a Canteen, an Auditorium, a garden, security, health etc.

The physical infrastructure of the institution consists of 13 studios (classrooms with drafting boards and wi-fi facility) for undergraduate, 2studios (classrooms- drafting boards with wi-fi) for Post Graduate (M. Arch in Architecture Education), 5 seminar halls (with LCD facility and wi-fi) and 7 laboratories (with required instruments). The Computer Lab possess 60 computers. The institution has 100 Mbps Bandwidth for internet connectivity (Optic Fibre, Lease Line, BSNL). Enterprise Resource Planning (ERP) is procured from Cloudbased ERP from MasterSoft Nagpur.

Library has a rich compilation of all resources with SyNchRoniKInc'sSoftLib software for management. Reprography lab and Tuck shop facility is provided. The institute has fire fighting installations.

The Principal, Vice -Principal, and administrative officer discuss the requirements before allotting funds for various purposes and their optimal utilization.

The Institute ensures effective and optimal utilization of funds.

Creative Exercises

One of the important components of Architecture is Creativity. To strengthen creativity, the institution has established certain strategies:

Design projects are led by creative exercises.

Experiments related to creative exercises are conducted in the Brain Gym established by the college.

These help in enhancing creativity in design studios.

The methods of teaching creativity and experiential learning are required to be understood by every teacher of architecture. Thus, induction programs are institutionalised by our Institution. Induction programs for teachers of Architecture are conducted by the institution's team for various colleges in India & outside India.

Experiential Learning

The gap between theory and actual practice is accompanied by giving more importance to experiential learning and hands-on experience. They play an important role in architectural education and can be applied to each subject.

Educational tours in the architectural curriculum are major exercises in experiential learning. Students on such visits are exposed to various architectural issues and gain knowledge.

As an institution, we strongly believe that in technical subjects like construction, materials, structures, and services, students should get hands-on experience or experiential learning.

The Internal Quality Assurance Cell (IQAC) evaluates the quality of design projects in all studios using established Standard Operating Procedures (SOP):

- **Initial Meeting**: At the session's start, design teams

present their projects, including objectives and expected outcomes.

- **Periodic Reviews**: Regular reviews are scheduled, with submission dates announced.
- **External Evaluators**: External reviewers assess the projects.
- **Expert Opinions**: Feedback from experts is gathered, and an exit meeting is held to discuss the quality of work.
- **Feedback Utilization**: Peer and expert feedback is used to enhance objectives and processes for the next semester.

These procedures ensure a structured evaluation of design projects.

Building Construction

Building construction is an integral part of the architecture.

Conventionally subject of construction was taught as a theory subject and focused on drawing sheets to improve students' understanding. To improve the quality of drawing sheets and the understanding of students, Institute has developed a Policy that stated that:

- Students will work on sheets during the class itself and tests would be conducted, in which drafting questions will be compulsory to give practice to students.
- Experiential learning sessions like site visits and hands-on experience i.e., construction yard activity, the industrial visit is made mandatory.

Solid Waste Management: The institute emphasizes proper segregation of waste at the source with separate bins for dry and wet waste. Collected waste is handed over to the municipal waste collection agency. Organic debris and waste paper are processed in compost pits to produce manure for gardening and landscaping.

Liquid Waste Management: Campus sewage water is managed through a proper drainage system, directing sewage and sullage to septic tanks for safe disposal. A grease trap outside the hostel kitchen intercepts grease and solids, preventing blockages and maintaining drainage efficiency.

Biomedical Waste Management: Sanitary waste from the hostel and college premises is managed through incinerators installed in toilets, ensuring safe disposal of sanitary pads.

Waste recycling system: Old newspapers, used papers, journal files, and workshop scrap materials are sent to external agencies for recycling.

E-Waste Management: Electronic waste generated on campus is collected and sent to an authorized e-waste recycler, for environmentally responsible recycling.

Hazardous Waste Management: The campus generates no significant hazardous or radioactive waste, ensuring minimal environmental impact.

Winter Drawing Competition The 15th Annual Winter Drawing Competition, organized by SMMCA, promotes awareness of architecture and environmental issues among school children and the general public. Its objectives include introducing architecture as a profession across diverse age groups and fostering creativity through engagement with socioenvironmental themes. Participants, ranging from nursery to 12th grade, are categorized by age, and themes are tailored to contemporary issues. The event attracts 400-600 students annually, with schools now eligible for a "Maximum Participation Award" to acknowledge their contributions. Despite logistical challenges, such as extensive communication with schools, the competition has consistently enhanced students' creative abilities and architectural awareness, highlighting interdisciplinary learning.

Vertical Studio - Bamboo Workshop The Vertical Studio on Bamboo Workshop, held annually at SMMCA, focuses on sustainable construction practices. It introduces students to bamboo as a renewable building material with high tensile strength. From March 12-14, 2024, vertical groups of students participated in practical sessions on bamboo properties, joinery techniques, and structure construction. The workshop,

supported by the Bamboo Development Board, improved students' understanding of sustainable materials and teamwork. Despite initial challenges, such as unfamiliarity with bamboo and time constraints, it successfully produced stable and aesthetic structures, fostering eco-consciousness and interdisciplinary collaboration.
